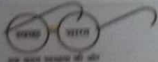

1. The school will be inspected by the Inspection Committee constituted by the Board after three months.
2. The school will provide additional suitable facilities for classes XI and XII, as per requirements.
3. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
4. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website:www.cbse.nic.in.
5. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
6. It will provide adequate co-curricular and extra-curricular activities for the wholesome development of the students.
7. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
8. It will continue to pay Annual Fee of Rs. 5000/- p.a. The schools run by KV/NVS/CTSA/Govt./Govt. Aided/Railways/Armed forces etc. are granted regular affiliation and apply online for Extension of Affiliation through link provided on Board website-www.cbseaff.nic.in.

1. As the schools are being considered conditionally on receipt of the request from Sh. Dr. R.
